2. Will there be a need to get the areas back in presentable shape? Yes, please include any initial onboarding or start up costs as a separate line item to the monthly fees in the bid.
3. What type of water source is the irrigation system? The irrigation for our Administration Office and US Customs Office is municipal water and Airport Road areas are on a reclaim system.
4. Is the species list indicated in Addendum #1 all inclusive and what sizes do you expect? Addendum 1 listed what was installed in the original plans for each location. BRAA is open to other species if they are not a wildlife attractant and are generally like for like in size to the current plantings.
5. Can we specify the minimum number of visits for each season? Change section 1 of Scope of Services to Mow, trim, weed, and keep clean all areas weekly year-round.
6. Bidder shall provide line-item pricing for a water truck as a per visit basis.
7. What is the budget for this? We do not have a defined budget at this time but expect the property to be maintained in pristine condition in keeping with local standards. The current landscaping agreement is attached for reference.
